9. That Health Certificate shall be obtained from M.C.D. within a month.

6. That adequate sports material shall be purchased and made available to the students.

8. That the school shall not run any unrecognised classes or any non-educational activities within the school premises and all the recognised classes shall be run at one place at the above address only. Nursery classes be removed from the premises of the school immediately, if any.
9. That the school shall dispense with the service of unqualified and over-aged staff, if any, immediately.
10. Fresh Health Certificate from MCD be obtained and produced to Education Officer for verification.
11. 12. The Managing Committee of the school shall not increase/enhance fee during the ensuing academic session without the prior approval of Director of Education which is a mandatory requirement under sub-section(3) of section 1 of Delhi School Education Act, 1973.
13. That all the facilities prescribed under Rule 50 & 51 of the DSER 1973 shall be made available to the students.
14. That the management of the school shall create a Reserve Fund as per DSE Act and Rules, 1973.
