8. That the enrollment in each section shall not exceed the number of students calculated @ 12 sq.ft. per student for the available floor area of the class-room and the school shall provide adequate and sufficient classrooms as per the norms of the Directorate of Education, Delhi in each class.
9. That Health Certificate shall be obtained from "Central School" within a month.
